## **Island Iron Small Boat Race:**

In consideration of CSCRC accepting my application and race fee, and being permitted to participate, volunteer or officiate in the CSCRC event and other activities associated with this event, I agree to this release of claims, waiver of liability and assumption of risk (collectively, this Agreement).

I acknowledge that the enjoyment and excitement of the CSCRC event is derived, in part, from the inherent risks associated with such activities beyond the accepted safety of life at home or work and that these inherent risks contribute to such enjoyment and excitement, being a reason for my participation.

I accept all the inherent risks of the CSCRC event and the possibility of personal injury, death, property damage or loss resulting there from.

I am aware that the CSCRC event in addition to usual dangers and risk associated with outdoor recreation activities has certain additional inherent dangers and risks some of which may include but are not limited to:

- Physical exertion for which I may be prepared;
- Weather extremes subject to sudden and unexpected change;
- Dangerous waters including rapids, whitewater and cold waters;
- Collision with other boats including other race boats and as well as commercial boat traffic or pleasure.

I waive any and all claims I may now and in the future have against and release from all liability and agree not to sue or allow my executors heirs or insurers to sue CSCRC and its officers, members, employees, guides, coaches, volunteers, agents, sponsors, or representative (collectively its staff) for any personal injury, death, property damage, or loss sustained by me as a result of my participation in any CSCRC event due to any cause whatsoever, including without limitation, negligence on the part of CSCRC or its staff. I acknowledge that I can, if I wish, purchase personal accident insurance to compensate me or my heirs for any personal injury, death, property damage, or loss sustained as a result of my participation in any CSCRC event.
